### Dress code

Men: knee length shorts, T-shirts, during exercises; long pants, chest protector and all protective equipment, during fencing.

Women: shorts with spandex underneath, T-shirts/tanks and padded bras during warming up and exercises; long pants, chest protector and all protective equipment, during fencing.

### Behavior

Fencers must behave in a sportsmanlike manner, at all times. Behavior that would get you a warning or yellow card at a competition, will get you a warning or yellow card at the camp. This includes but is not limited to the following prohibitions:

*.Swearing. .Name calling. .Negative talk. .Throwing equipment. .Hitting or kicking the floor/walls. .Yelling. .Misuse of equipment. .Any sort of bullying.*
